This is a family run business and we had been providing for several employees. Facing this recession has caused me to let my employees go. Many people are hoping the economy picks up but that's not the case for Perc dry cleaners. I have been using Perc as my dry cleaning solvent for years. It has cleaned my clothes as well as my customers taking out spots, keeping color and etc. My friends who use other solvents have to use extra solvents to pre spot and still spots do not come out. If this is the case, why would anyone come to the dry cleaners? Personally, I would not go if spots do not come out.

If SB1617 passes, this may cause me to run out of business. I am barely keeping up with my bills. I have been late paying rent and begged the landlord to lower the rent. Even so my utilities bills are late, house payments, my children's college tuitions, and etc. Passing SB1617 will force me to purchase a dry cleaning machine as soon as the bill passes. I understand that if the bill is passed there is a decent amount of years but that's only on paper. My customers will not want their clothes cleaned with a solvent that is banned and I can not sell unless I reduce the cost of the new machine. I do not have the money to invest in a new machine therefore the selling value of my facility is over \$75,000 less now. I can not i to support my family if I can not even sell my facility. The minimum 80 hours a week that my family and I have put into my business weekly for years has now been a waste.

I have tried several things to improve my business and attract people to come into my facility such as making a website, sending out coupons, advertising in local newspapers/schools/television and etc but it has not helped with the income. My customers have been laid off and have more time to prepare their own clothes instead of bringing them into my dry cleaning facility. People have been reluctant to spend money and still can not save. I was looking forward to 2011 since the economy was supposed to be rising but in my industry is seems to have made a different impact. My business has been facing more hardships than 2010. My heart is breaking to the thought that SB 1617 might be passed. This will cause me and most of my industry to go out of business.

Please protect our livelihood by voting against SB 1617. Please consider my industries situation as a small family owned business.

As a family-run dry cleaners, we have been barely surviving through the current economic turndown. However, by tightening our belts and cutting expenses, we will hopefully make it to the other side of these hard times. If SB 1617 is enacted into law, it will be a damaging blow to family run dry cleaners. We, and others like us, would have a tremendous capital expenditure in the coming years, in order to meet the new requirements. The manufacturing companies that produce alternative dry cleaning machines/solvents, would have tremendous leverage over the small businesses, due to their size and because we small businesses would have no choice. The expense of purchasing a new \$60,000+ dry cleaning machine is not something we can afford now during the economic downturn, and will not be one that we can make once the economic recovery takes place. If we are forced to make this type of expenditure, the big business corporate run dry cleaners will have a substantial leg up on us, with their greater ability to raise capital.

Even more importantly, many of the current owners of dry cleaners are first generation immigrants, who are part of the baby boomer generation. They are nearing retirement age, and many are counting on selling their business as part of their retirement fund. If SB 1617 passes, the most important asset of the business would become obsolete, impairing the value of the business. As an owner that is relying on the sale value of my business for my retirement, please consider the impact of SB 1617 on hard working Americans like me.

Please help preserve one of the few remaining family run industries. Please vote against SB 1617. Thank you for taking the time to consider my concerns.
